SEPTEMBER 12th. 1928.

Pursuant to the order of adjournment, the Board of County Commissioners met on Wednesday, September 12th. 1928, with all members present. W W Stuckey, Chairman, W L North and Ed W Hedgecock, Members.

Reading of the minutes of the previous meeting was dispensed with and there being no objections to the same, they were ordered to stand approved.

The matter of the dissolution of School District Number Nine (9) of Tulsa County, and the annexation of the territory comprising said District of Independent School District Number Twenty Two (22) and Twenty Seven (27), was taken up and the following Journal Entry made:

JOURNAL ENTRY.

BE IT REMEMBERED: That on the 19th. day of September, 1928, the above matter came on for hearing upon appeal from the order made, entered and promulgated on the 31st. day of August, 1928, by the Honorable A G Bowles, as County Superintendent of Public Instruction of Tulsa County, Oklahoma, before the Board of County Commissioners of Tulsa County, at the hour of 9:30 O'Clock A M, all members being present, appellants appearing in person and by Everett Petry, their attorney, and appellee School District No. 27, appearing by Louis W. Pratt and James Harrington, its attorneys, and appellee, A G Bowles, as County Superintendent of Public Instruction appearing by Hugh Webster, Assistant County Attorney, whereupon upon agreement of the parties the cause was continued to Wednesday, the 12th. inst., at 10 O'clock A M., and now, to-wit: The day and hour heretofore fixed and appointed for said matter having arrived, all members of said Board of County Commissioners being present, and the respective parties by their counsel announced as being ready, the cause proceeded to trial, thereupon appellants offered their evidence to sustain their respective objections and specifications as set forth in said notice of appeal and rested. Whereupon appellees offered their evidence and rested, upon the conclusion of which the points in controversy were by respective counsel fully argued and submitted the matter to said Board of County Commissioners for consideration and judgment and said Board of County Commissioners now well and fully advised in the premises, a majority finds the issues herein in favor of appellees and against appellants and finds:

That on the 31st. day of August, 1928, there was presented to appellee A G Bowles, as County Superintendent of Public Instruction of Tulsa County, Oklahoma, a petition signed by a majority of the qualified electors of School District No. 9, being the territory affected and the subject matter of this controversy wherein request was made by the individuals signing said petition, that the boundaries of said School District No 9 be, by said County Superintendent of Public Instruction changed in the particulars as in said petition prayed and set forth; that a majority of said Board finds that the acts of said County Superintendent in granting the request of said petitioners in making, entering and promulgating his order to that effect was for the best interest of the patrons of School District No 9, likewise for the best interest of School Districts Nos. 22 and 27, respectively, and that said County Superintendent acted in good faith in the exercise of a legitimate discretion which was in its nature quasi-judicial and a majority of said Board finds said action was neither arbitrary or fraudulent and that the same should be and is hereby approved.

IT IS, THEREFORE, ORDERED, CONSIDERED, ADJUDGED AND DECREED by a majority of said Board of County Commissioners that the acts, doings and proceedings of said A G Bowles, as County Superintendent of Public Instruction of Tulsa County in changing the boundaries of said School District as made, contained and set forth in the order by him made and promulgated on the 31st. day of August, 1928, agreeable to and in conformity with the request of a majority of the qualified electors of said territory be and the same is in all things hereby approved and said order so made, entered and promulgated is hereby made a part hereof by reference as fully as if incorporated and set out herein at large, and it is further ordered, considered, adjudged and decreed that appellants take nothing by reason of this proceeding.
