Motion was made by Commissioner Gray, seconded by Commissioner Bridges, that JOHN J SEVRA be and he is hereby appointed on the Night Force of Janitors at the Court House. Motion carried.

Motion was made by Commissioner Bridges, seconded by Commissioner Gray, that Mrs.Lou Henry be and she is hereby appointed Head Supervisor in the Welfare Department replacing Mr.A.M.Welch. Motion unanimously carried.

MEMORANDUM OF AGREEMENT FOR EXTENSION WORK. Between the Board of County Commissioners of Tulsa County and the Extension Division of the Oklahoma Agricultural and Mechanical College.

OBJECT:

TULSA COUNTY AND THE EXTENSION DIVISON OF THE Oklahoma agricultural and mechanical college. Co-operating with The United States Department of Agriculture.

For the purpose of assisting farmers and farm families of Tulsa County with the many problems of farming, home-making and community life, the Extension Division of the Oklahoma Agricultural and Mechanical College and the Board of County Commissioners of said County, acting under authority of law, enter into this contract for carrying on cooperative demonstration work in agriculture and home economics, including 4-H Club work, in Tulsa County during the hear beginning July 1st.1933 and ending June 30th 1934.

METHOD OF PROCEDURE:

For the objects expressed above, the Oklahoma Agricultural and Mechanical College, cooperating with the United States Department of Agriculture, shall select the agent or agents to be employed such persons to be well qualified to fill these postions by training, education and experience, whoc shall be satisfactory to the Commissioners of said County.

COUNTY FUNDS AND EQUIPMENT:

The County Commissioners agree to pay One Hundred Fifteen (\$115.00) Dollars per month on the salary of a County Agricultural Agent, and Fifty Dollars (\$50.00) per month on the salary of a County Home Demonstrator Agent for a period of Twelve months beginning July 1st. 1933. The County Commissioners further agree to furnish an office and to appropriate the following amounts to apply on the expenses: For the County Farm Agent \$1,000.00; for the County Home Demonstration Agent \$400.00; for office Assistant \$1,500.00; for salary Special Office Help for one month \$75.00; the expenses to be paid monthly andthe total amount paid in one month not to exceed the proportionate part of the year the agent has worked.

COLLEGE FUNDS AND EQUIPMENT.:

In addition to the funds furnished by the County, the Extension Division of the Oklahoma Agricultural and Mechanical College, cooperating with the United States Department of Agriculture, will pay One Hundred Ten Dollars (\$110.00) per month on the salary of the County Farm Agent, and will pay One Hundred Ten Dollars (\$110.00 per month on the salary of the County Home Demonstration Agent, The Extension Division of the A & M College also agrees to furnish all Agents employed with the franking privilege for the free use of the mails in sending of agricultural publications in the County, to furnish the Agents necessary stationery, instructions and printed bulleting for the use of farmers in the County, both from the College and from the United States Department ofmAgriculture.

SUPERVISION:

The Extension Division of the Oklahoma Agricultural and Mechanical College will supervise the work of these agents, carefully looking after the same to see that the work is done efficiently and in a manner to be of the largest possible benefit to the people of the County, and to pay the expenses of the agents when they are authorized to attend meetings outside of the County on official business.

SPECIAL AID:

The said A & M College likewise agrees to send tothe County Special representatives and to assist these agents on special tasks, and to hold educational meetings for the benefit of the farmers and to assist in every possible way in making the work in the county effective.
