RESOLUTION

WHEREAS, The Tulsa County Highway Department has found that signs should be posted on all County 1946 Bond Issue roads as well as all Farm to Market, Federal Aid Secondary roadways for the purpose of controlling the type of traffic traversing the roadways in Tulsa County.

NOW, THEREFORE BE IT RESOLVED, That suitable signs be prepared and posted at each and all of Tulsa County 1946 Bond Issue roads as well as all Farm to Market Federal Aid Secondary roadways in the county, built or to be built, all for the purpose of limiting the loads that may traverse such highways to preserve and lengthen the life of such roads by controlling the type of traffic as to loads and over-loads.
