Zoning Application CZ-309, Owner Rex J. Lee, Applicant Stephen Schuller, Location: Northwest corner W. 4<sup>th</sup> St. N. & N. Terrace Dr. This request for re-zoning was denied by Tulsa Metropolitan Area Planning Commission on July 3, 2002 & applicant has paid \$15 appeal fee as prescribed in O.S. §1730.4. Chairman asked if anyone was present other than the applicants and wished to speak. Dane Matthews, TMAPC, briefly stated their position in this matter. Stephen Schuller, attorney for the owner, explained their position regarding the location, surrounding residential area and businesses in the vicinity. Fred Leeds spoke for the owner, stating his reasons for supporting the rezoning request. The following protestants stated their objections to the requested re-zoning: Louise Osborn, 401 Terrace Drive, Sand Springs, OK 74063; Janis Harrington, 1014 Ridge Drive, Sand Springs, OK 74063; Mrs. Bobbie Davis, 601 Loop Drive, Sand Springs, OK 74063; Harlan Harrington, 1014 Ridge Drive, Sand Springs, OK 74063; and Kenneth McKinney, 1011 Wekiwa Road, Sand Springs, OK 74063, who also presented additional letters and photos not previously submitted to the Planning Commission. Mr. Schuller presented his rebuttal, including stating the photos presented were not of property owned by Mr. Lee. The Commissioners stated their positions in the matter.
