

THURSDAY, JANUARY 4, 1945

Pursuant to a recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock A. M., Thursday, January 4, 1945, with all members present. Curtis Greer, Chairman, J. B. Gray, Robert L. Kinkaid, Members. Andy Stokes, County Clerk.

Curtis Greer, Chairman presiding, the following business was transacted.

Motion made by Commissioner Gray, seconded by Commissioner Greer, to cancel warrant #382, Claim #362460, Account #1, in the sum of \$10,750.00 issued to Ottinger Brothers on December 6, 1944, to cover construction of a Multiple Box Culvert at the crossing of the Tulsa-Sapulpa Highway and the New Cherry Creek Channel of the Tulsa Drainage District #12, and a warrant^{be} issued to Ottinger Brothers in the amount of \$10,000.00 in accordance with a Court Order of Oras A. Shaw, Judge of the District Court. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried. Court Order-File #47453

Motion made by Commissioner Gray, seconded by Commissioner Greer, that a warrant for \$750.00 be issued to Ottinger Brothers, to cover the balance due on the construction of a Multiple Box Culvert at the crossing of the Tulsa-Sapulpa-Highway and the new Cherry Creek Channel of Tulsa Drainage District #12, in accordance with Court Order of Oras A. Shaw, Judge of the District Court. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried. Court Order-File #47453.
