

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that the refund of \$38.50 covering claim #47718 - Tommy Hopson, and Claim #44720- Christine Hopson, from Mercy Hospital covering hospital care in August 1950, be accepted and deposited with the Co. Treas. This charge has been collected by the hospital from the patients.

Motion made by Commissioner Couch, seconded by Commissioner Bailey, and unanimously carried, that upon the recommendation of the Acting County Engineer, Project No. 2-N covering the Proposal and Plans for the Grading and Drainage West of 21st Street, from the west end of the pavement in Section 8, Township 19-North, Range 12 East in Tulsa County; thence west along the Arkansas River 1.25 miles, be, and the same is hereby approved, and that the County Clerk be authorized to secure sealed Bids, to be received up to 9:00 o'clock a. m., Friday, December 29, 1950.

Motion made by Commissioner Bailey and seconded by Commissioner Couch and unanimously carried, that the resignation of Earl U. Miller, elected Justice of the Peace in District 4, Division #2, Tulsa County, on November 7, 1950, be and the same is hereby accepted, and that J. P. Gunter be and he is hereby appointed to fill the vacancy. Also that the bond in the amount of \$1,000.00 and made by the Continental Casualty Company, filed by Mr. Gunter, be and the same is hereby approved.

Motion made by Commissioner Hardesty, seconded by Commissioner Couch, and unanimously carried, that the License entered into on May 17, 1943, be and between the Board of County Commissioners of Tulsa County, Oklahoma, and the United States of American, for installation of a railroad spur crossing over a public road in connection with Modification Center No. 16, Tulsa County, be, and the same is hereby cancelled, and the Chairman of the Board is hereby authorized to sign the Release.

RESOLUTION

WHEREAS, in Common Pleas Court Case No. 64,752, C. V. Kulbeth was charged with the offense of Attempted Second Degree Burglary, and upon being bound over for trial to the District Court of Tulsa County for said offense, posted a \$2,000.00 bail bond for his appearance for trial in District Court; and
