Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the applications filed by the City of Tulsa and approved by Garrett Newman, County Assessor, to strike the taxes on the following described property from the rolls, be approved and the Chairman is hereby authorized to sign the orders striking the taxes.
