It was moved by Commissioner Gray, that the Chairman of the Board notify by letter all drug stores, undertakers, hospitals and physicians heretofore handling charity work for the County, that the funds appropriated for charitable purposes for the fiscal year 1935-36 have been exhausted and that no further funds are available for the payment of bills for such charitable work, and that any such work done from May 18th, 1936, until the end of the fiscal year June 30th, 1936, will necessarily be done at the risk of those doing same; that the Board of Jounty Commissioners and the members of the Board individually assume no responsibility for the payment of such bills, and that they are unable to say whether same will ever be paid. Motion was seconded by Commissioner Hopkins, and upon roll call, all members voting in the affirmative, motion was declared carried.

The following letter was directed to the county physicians.

Dear Doctor:

The County Commissioners in regular session this the 18th day of May, 1936, wish to inform you that on and after this date the County or County Commissioners will not be responsible for any obligation or indebtedness created by you.

We are quite sure that we will be able to secure sufficient funds the middle of June in our supplemental appropriation to meet these obligations but at this time we can not say for sure. We appreciate very much the splendid work that you have done in behalf of the County and County Commissioners and we are making every possible to pull through the year ending June 30th, 1936, without a deficit, and whatever assistance you may give between now and July 1st to the indigents of Tulsa County in your vicinity will certainly be appreciated by us.
