There being no further business coming before the Board at this time they adjourned to meet March the 19th 1918, at 9 o'clock A.M.

March 19th 1918.

The Board met in regular session all members being present. A resolution was made by R.A.Martin and seconded by C.E.Suppes and W.L.North that the County Clerk be instructed to advertise for the sale of \$1,400,000.00 of road bond issue, which was voted November 20th 1917, said bonds to be offerred in amounts of \$700,000.00, beginning with the series of 1924 and ending with the series 1933 inclusive, and the issue beginning with 1934 and ending with the series 1943, that the said Bonds to be advertised in the Tulsa World and the Bond Issue. Said order approved this the 19th day of March 1918.

An order was made by the Board of County Commissioners that the sheriff be directed to tear down and remove from the Roadway at the East Approach of the Arkansas Bridge and destroy the building, as said building is a nuisance and a menace to the health of the community.

There being no other business coming before the Board at this session they adjourned to meet on their regular meeting day Monday April 1st,1918. at 9 o'clock A.M.

Monday April 1st, 1918.

The Board of County Commissioners met in regular session on Monday April 1st, 1918. at 8 o'clock A.M. in their rooms in the County Court House. Present C.E. Suppes, W.L. North, and R.A. Martin, with Lewis Cline County Clerk and clerk of the Board.
