

Said right of way to include the right to cross all highways and roads intersecting any part of the routes above indicated.

This consent, however, being subject to the following conditions, rules and regulations.

The said Consolidated Pipe Line Company shall place and maintain its pipes, upon, along, across, and under such highways, under the supervision and subject to the rules and regulations of the Board of County Commissioners and the County Engineer and not less than thirty (30) feet from the section lines and shall, at all times, keep said lines, in good repair and hold the county and citizens thereof harmless from any and all damages caused by the construction or maintenance of said lines.
