O R D E R

This matter came on for hearing this 23rd day of October, 1941, on affidavit of erroneous assessment filed on behalf of First Bancredit Corporation by C. H. Froehle, Manager, and it appearing that the Taxpayer made a return of accounts receivable and securities for intangible tax purposes of the value of \$18,790.97, that the Assessor raised said assessment to \$1,216,788.00, and the County Board of Equalization of Tulsa County, Oklahoma, sustained a complaint of the taxpayer and reduced said assessment to the amount fixed by the taxpayer, and the County Assessor has appealed from the judgment of the Board of Equalization to the District Court, where the matter is now pending, and that in order to pay the taxes according to the assessment fixed by the Board of Equalization, the valuation of said accounts receivable and securities should be reduced by \$1,197,997.00 and the amount of taxes assessed should be reduced by \$4,791.99.

IT IS ORDERED that said affidavit of erroneous assessment be and the same hereby is sustained and the assessment roll is corrected accordingly, but without prejudice to the County in the event it shall be adjudged on appeal that the assessment should be increased.

O R D E R

Now on this 23rd day of October, 1941, the above matter came on before the Board of County Commissioners of Tulsa County, upon the application of Fredericks Gerlach, for an order of said Board correcting the order of the Equalization Board dated the 2nd day of June, 1941, and it appearing to the Board of County Commissioners in regular session, that the application for reduction of assessment heard on the 2nd day of June as aforesaid, described the South Half of Lot 6, Block 167, Original Townsite of the City of Tulsa, when in truth and in fact it should have described the North Half of said lot, and it having been made to appear to the Board of County Commissioners by affidavit, that the applicant was and is not the owner of the South Half of said Lot, but owns in fee simple the North Half of said Lot 6, Block 167, Original Townsite to the City of Tulsa, and that the order so made by the Equalization Board on the 2nd day of June, 1941, in pursuance of the application was erroneous.

NOW, THEREFORE, IT IS ORDERED AND DECREED by the Board of County Commissioners that said order and said assessment rolls be corrected so as to apply to the North half of Lot 6, Block 167, Original Townsite of the City of Tulsa, instead of the South Half of said Lot 6, and that the reduction of One Thousand and Eighty Dollars in assessment apply to the North Half of said Lot 6 instead of the South Half thereof.
