

Resolution and order introduced,
providing for calling an election.

Resolution and order adopted.

Bridge No. 62 — 36 X 14 ft. steel span. Located across branch of Hippy creek between sections 21 & 22, Township, 18 North, Range 14 East.

Thereupon Commissioner C. H. Cleveland introduced a resolution and order entitled, "A resolution and order providing for the calling and holding of an election in Tulsa County, Oklahoma, on the 12 day of October A.D. 1909, for the purpose of submitting to the qualified electors thereof the proposition of issuing the negotiable coupon bonds of said County of Tulsa to the amount of \$75,000.00 to provide the necessary funds for the construction of bridges in and for said county; & levying and collecting an annual tax upon all of the taxable property in said county, sufficient to pay the interest on and the principal of said bonds when due, which resolution was read in full by the clerk. Moved by C. H. Cleveland, seconded by Geo. Mc Keehan, that said resolution and order be adopted and passed as read.

The question being put to vote, the roll was called with the following result:

Those voting "aye" C. H. Cleveland, Geo. Mc Keehan, W. L. North.

Those voting no: None.

And the motion was, by the chairman, declared carried, and the foregoing resolution and order adopted.

And whereas, the needs and interests of the said county demand the immediate construction of said bridges; & Whereas there are no funds in the county treasury available for the construction of said bridges; and in order to provide the necessary funds for such purpose it is deemed and hereby declared necessary for said county to issue its negotiable coupon bonds under and pursuant to the constitution of the State of Oklahoma and of an act passed by the Oklahoma legislature on March 10, 1909 approved and in force March 19, 1909, entitled; "An Act to enable the county commissioners of any county in the State of Oklahoma to issue the bonds of such county for the purpose of building, constructing, repairing or acquiring bridges and declaring an emergency; & Whereas, it appearing from the Plans, specifications and estimates hereinabove mentioned, that the estimated cost of the construction of said bridges will be \$75,000.00 now therefore be it,

Resolved And Ordered by the Board of County Commissioners of the County of Tulsa in the State of Oklahoma: Section 1 That a special election be and the same is hereby called, to be held in the County of Tulsa in the State of Oklahoma, on the 12 day of October A.D. 1909, for the purpose of submitting to the qualified electors thereof the proposition of issuing the negotiable coupon bonds of said County of Tulsa, to the aggregate amount of \$75,000.00 in order to provide the necessary funds for the construction of public bridges as a part of the public highway system, in and for said county - said bridges to be located as follows:

Bridge No. 35 - 30 X 14 ft. steel span. Located across Branch of Schaloll creek, between sections 1 and 12, township 22 north, range 12 east.

Bridge No. 36 - 80 X 14 ft. steel span, Located across Schaloll creek, between sections 11 and 12, township 22 north, range 12 east.

Bridge No. 37 - 190 X 16 ft. steel span, with an 80 X 16 ft. and 18 X 16 ft. steel approach. Located across Bird creek, between sections 11 and 12, township 22 north, range 12 east.
