## RESOLUTION

WHEREAS, Osage County, State of Oklahoma, proposes to sponsor a Works Projects on the Tulsa-Osage County line, beginning at the south corporate limits of the Town of Skiatook and extending south to the southeast corner of Section 27, Twp. 22N,R.12East, and

WHEREAS, the Works Progress Administration, by reason of the fact the proposed project involves work on both Osage and Tulsa County, requires that Tulsa County show by a resolution that Osage County is given the provilege and the right to build and maintain a public highway along the above mentioned County line, such class of work being that proposed in the sponsor project.

NOW, THEREFORE, BE IT RESOLVED that the principle, whereby a County is presumed to care for the highways along its east and northern boundaries be herein affirmed and that Osage County, by this resolution, is authorized to carry out public road construction and to thereafter maintain the same, along the boundary line between Tulsa and Osage County, beginning at the Northwest corner of Tulsa County and extending south to the southeast corner of Osage County and particularly from the south corporate limits of Skiatook south along said County line to the southeast corner of Section 27, Township 22 North, Range 12 East, that this resolution may conform specifically to the project as proposed by Osage County to the Works project Administration.
