Gentlemen:

The undersigned, having examined the plans, specifications, location and character of the work to be done and performed, hereby proposes to furnish all labor, materials and equipment, and to complete strictly in accordance with the plans and specifications (Oklahoma Standards) and according to the instructions and directions of the County Engineer, the hereafter described bridge, based on the Engineers approximate estimate of quantities, at the unit prices herein set forth; it being provisioned that the size of said opening may be altered by the County Engineer, and this proposal optional with your Board, may be extended to cover other and similar work in or near the same vicinity, at the same unit item prices as herein set out; proposal as follows:

One 12X3X20 Foot I Beam Concrete Bridge, between Section 7 & 18, Township 20 North, Range 14 East, Dawson Township.
