such employment on the terms and conditions hereinafter set forth, and

WHEREAS, the Tom of Buffalo has heretofore made a tentative offer of 25% of the principal, i.e. \$8,750.00, but that Tulsa County has refused to take said sum in settlement.

NOW, THEREFORE, party of the first part, by resolution duly passed and adopted, and by these presents does hereby agree to pay to the party of the second part, a sum equal to twenty per cent (20%) of any and all sums collected, received and secured by compromise settlement, judgment or any other means, arising out of or from or in any wise appertaining to said bonds above mentioned, over and above the sum of \$8,750.00, in consideration of which party of the second part does hereby accept employment in the litigation above mentioned and does hereby agree to prosecute with due diligence and to final conclusion any and all actions as may be by him and the County Attorney deemed necessary for the full protection of the rights of the party of the first part and in and to the matters above set forth, provided, that the County Attorney shall have control of the litigation with power to settle and compromise at any time.
