Bridge no. 58 - 40x14 ft. steel span. Located across Branch of Higgy creek, between sections 16 and 21, township 18 north, range 14 east.

Bridge no. 59 - 50x14 ft. steel span. Located across Branch of Higgy creek, between sections 17 and 20, township 18 north, range 14 east.

Bridge no. 60 - 30x14 ft. steel span. Located across Branch of Higgy creek, between sections 17 and 20, township 18 north, range 14 east.

Bridge no. 61 - 50x14 ft. steel span. Located across Branch of Higgy creek, between sections 19 and 30, township 18 north, range 14 east.

Bridge No. 62 - 36x14 ft. steel span. Located across Branch of Higgy creek, between sections 21 and 22, township 18 north, range 14 east.

Election Proclamation,

By virtue of the authority conferred by the constitution and laws of the State of Oklahoma and pursuant to a resolution and order duly adopted and passed by the Board of County Commissioners of the County of Tulsa, in the State of Oklahoma, at a regular session thereof held on the 10th day of August A.D. 1909, public notice is hereby given that a special election will be held in said County of Tulsa on the 12th day of October, A.D. 1909, for the purpose of submitting to the qualified electors of said county the proposition of issuing the negotiable coupon bonds of said Tulsa County, Oklahoma, to the aggregate amount of \$15000⁰⁰, for the purpose of providing the necessary funds for the construction of twenty-eight (28) bridges as a part of the public highway system in and for said county - said bridges to be located as follows, to wit:

Bridge no. 35 - 30x14 ft. steel span. Located across branch of Schaloll creek, between sections 1 and 12, township 22 north, range 12 east.

Bridge no. 36 - 80x14 ft. steel span. Located across Schaloll creek, between sections 1 and 12, township 22 north, range 12 east.

Bridge no. 37 - 190x16 ft. steel span, with an 80x16 ft. and 18x16 ft. steel approach. Located across Bird creek, between sections 11 and 12, township 22, north range 12 east.

Bridge no. 38 - 80x14 ft. steel span. Located across Fenwick creek, at the corner of sections 13 and 18, 19 and 24, township 22 north, range 12 and 13 east.

Bridge No. 39 - 60x14 ft. steel span. Located across Slough, between sections 19 and 30, township 22 north range 13 east.

Bridge no. 40 - 36x14 ft. steel span. Located across Cherry creek, between section 24 and 25 township 22 north, range 13 east.

Bridge no. 41 - 190x16 ft. steel span, with an 80x16 ft and 18x16 ft. steel approach. Located across Bird creek between sections 20 and 29 township 21 north range 13 east.

Bridge no. 42 - 75x14 ft. steel span. Located across Delaware creek, between sections 25 and 30, township 21 north, ranges 12 and 13 east.

Bridge no. 43 - 80x14 ft. steel span. Located across Flat Rock creek between sections 8 and 9, township 20 north, range 13 east.
