J. W. Hardesty, Chairman, presiding, the following business was transacted.

Motion made by Commissioner Caffey, seconded by Commissioner Bailey and unanimously carried that J. H. Bolton be appointed in the Highway Department of District No. 2.

Motion made by Commissioner Caffey and seconded by Commissioner Bailey, and unanimously carried, that the resignation of Robert D. Sims, Justice of the Peace, District 11, Division 1 Tulsa County, be accepted, and that Matthew S. Sims be, and he is hereby appointed to fill the vacancy; also that the Bond filed by Matthew S.
