of water on the said hard surfaced road and the lands immediately adjacent thereto.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter set forth and the payment hereinafter to be made, as hereinafter set forth, the parties hereto have agreed as follows:

- 1. That there shall be constructed a drainage pipe from the center of Section 12, township 19 north, range 11 east, to the Arkansas River; that the expense of laying said drainage pipe to accomplish said drainage purposes, as above set forth, shall be divided equally between the parties hereto.
- 2. That the expense of laying the pipe, including the cost of the pipe, will be twelve thousand (\$12,000.00) Dollars; that the Sand Springs Home will furnish all of the pipe as its half of the expense, the reasonable value of said pipe being the sum of SixThousand (\$6,000.00) Dollars; the pipe to be used being wrought iron twenty inch pipe.
- 3. It is fruther agreed that the party of the second part shall lay said pipe and do all of the work necessary for excavating, laying said and back filling; said pipe to be paid and constructed so as to drain the hard surfaced road, as herein before set forth and to be laid from the point hereinbefore set forth, from the conter of said section twelve, township 19, range 11, to the Arkansas River; the work of laying same to be in a workmanlike manner, with proper manholes and inlets, and all of said work to be done at the cost and expense of the party of the second prt.
- 4. it is further agreed that said work shall be commenced within thirty (30) days after the execution of this contract, and to proceed with the work to completion as rapidly as possible. All of said work, and the laying of said pipe shall be subject to the inspection and approval of the County Enginner of Tulsa County, Oklahoma.
- 5. It is further agreed that after said drainage pipe shall have been laid and said work completed, and after same shall have been approved by the County Engineer of Tulsa County, Oklahoma, that the party of the first part will pay the party of the second part, as full consideration for the laying of said drainage pipe, the sum of Six Thousand (\$6,000.00) Dollars.
