DUNBAR SCHOOL PROPERTY.

Whereas, the County of Tulsa is now the holder of record title to certain lands occupied, or heretofore occupied by colored schools of the City of Tulsa, Oklahoma, and

WHEREAS, under House Bill No. 615, approved March 27th, 1917, adopted by the legislature during the year 1917 full control of the colored schools was transferred to the Boards of Education in cities of the first class, and the Board of Education of the City of Tulsa, of the State of Oklahoma has requested that title to the hereinafter described properties be conveyed by the County of Tulsa to the Board of Education of the City of Tulsa, of the State of Oklahoma.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF TULSA OF THE STATE OF OKLAHOMA, that the County of Tulsa transfer and convey to the Board of Education of the City of Tulsa, of the State of Oklahoma, by a conveyance executed by the Chairman of the Board of County Commissioners of Tulsa County and attested by the ~~Chairman of the Board of County Commissioners of Tulsa County and~~ County Clerk, the entire right, title and interest of the County of Tulsa in and to the following described properties, now, or heretofore occupied by colored schools within the limits of the City of Tulsa, to wit:

No. 1 - The Dunbar School Site described:

Commencing at the southwest corner of Block One of the North side addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof, running thence North along the west line of said Block 150 feet; thence East 270 feet, more or less to the west line of the Right of way of the Midland Valley Railroad; thence South along the west line of said right of way to the Southeast corner of Block 1; thence west along the south line of said Block 272.4 feet to the place of beginning.

No. 2. Lots 6 and 7 in block 3, in Davis-Wilson Heights addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof.

No. 3. Lots 1 and 2 the same being all of Block 16 in North Tulsa, an addition to the City of Tulsa, Oklahoma, according to the recorded plat thereof.
