The ballots to be used at said election will be in substantially the following form:

Shall the Board of County Commissioners of Tulsa County Oklahoma, issue the bonds of said Tulsa County in the sum of \$75,000⁰⁰ to bear interest at the rate of five per centum per annum, payable semi-annually, and the proceeds thereof to be used for the purpose of constructing bridges in and for said county; and levy and collect an annual tax upon all of the taxable property in the county in addition to all other taxes sufficient to pay the interest on the principal of said bonds as the same mature.

All as provided in the resolution and order adopted and passed by said Board of County Commissioners on the 10th day of Aug. A. D. 1907.
