Motion by Commissioner Miller, seconded by Mr. Gray, that France Paris be and he is hereby re-appointed member of the Tulsa Four State Fair Board for a period of four (4) years, appointment to be effective as of January 1st, 1937. All members voting in the affirmative, motion was declared carried.
