R E S O L U T I O N

WHEREAS, the law requires the County Commissioners to re-district the Justice of the Peace and Constable districts of Tulsa County in accordance with the act of the last Legislature. Motion by Commissioner Gray, seconded by Commissioner Morley, that the Justice of the Peace and Constable Districts of Tulsa County hereafter be as follows, to-wit: Motion carried.

- No. 1      Composed of the area included in the corporate limits of the town of Skiatook.
- No. 2      Composed of the area included in the corporate limits of the City of Collinsville.
- No. 3      All the territory of Tulsa County lying north of the north boundary of Township 19N, except the area within the corporate limits of the City of Tulsa, the Town of Skiatook and the City of Collinsville.
- No. 4      Composed of the area included in the corporate limits of the City of Tulsa (4 Divisions).
- No. 5      Composed of that area which begins at the NE corner of Section 1, Twp. 19N, Range 14E, thence west to the corporate limits of the City of Tulsa, thence in a southwesterly direction along the City limits of the City of Tulsa to the Arkansas River, thence southeasterly along the river to the west side of Section 18, Twp. 17N, Range 14E, thence north to the north boundary of Twp 18N, thence east to the County line, thence north to the point of the County line, thence north to the point of beginning.
- No. 6      Composed of the area included in the corporate limits of the City of Broken Arrow.
- No. 7      Composed of the area included in the corporate limits of the Town of Bixby.
- No. 8      Composed of the area which begins at the NE corner of Section 1, Twp. 18N, Range 14E; thence west to the township line, thence south along this line to and across the Arkansas river, thence in a northwesterly direction along the Arkansas River to the North boundary of Section 4, Twp. 17N, Range 13E, thence west to the County line, thence south along County line and continuing along the County line to the place of the beginning, except the areas included in the corporate limits of the City of Broken Arrow and the Town of Bixby.
- No. 9      Composed of the area beginning at the north boundary of Section 4, Twp. 17N, Range 13E, thence in a northwesterly direction along the Arkansas River to the West boundary of Twp. 19N, Range 12E, thence south to the Tulsa County line, thence east along the south boundary of County, thence south along west boundary of the Tulsa County line to the North boundary of Twp. 17N, Range 12E, thence east to the point of beginning, except the area in the corporate limits of the City of Tulsa.
- No. 10      Composed of all the area of Tulsa County lying north of the Arkansas River and west of the corporate limits of the City of Tulsa with the exception of the area within the corporate limits of the City of Sand Springs and all the area of Tulsa County west of the west boundary of Twp. 19N, Range 12E, lying south of the Arkansas river.
- No. 11      Composed of all the area within the corporate limits of the City of Sand Springs. (2 Divisions).
