The Commissioners met at 10:00 A.M. Tuesday, March 2nd, 1915, present - C.S.Avery, A.W.Lucas and Ed. Baker, Absent, Lewis Cline.

Appt. of An order was made appointing Robert Randolph, Roadoverseer of District Roadover- No.3, Bixby Twp. this to cover all territory lying east and south of Snake Creek seer Bixby in Bixby Twp.

It was moved by Ed. Baker and duly seconded that J.I. Moss be appointed Appt. Cattleattle Inspector for Tulsa County, his services to begin March 15th, 1915 at a Insptr. salary of \$100. a month.

Appt. J.P. It was ordered that C.W.Eaton be appointed Justice of the Peace for Skiatook Skiatook Twp.

Res. J.P. The resignation of A.L.Lawson, Justice of the Peace of District No.9, Jenks Twp Jenks Twp. was presented and accepted and the Clerk of the County was instructed to see that he return all books and records.

Court Records checked

It was ordered that the books of the Superior Court and the County Court be checked by the State Auditor, the expense not to exceed \$200.00.

The contract of I.M. Jackson, Undertaker of Norman, Okla., for the burial Undertaker of Tulsa County paupers confined at the Insane Asylum at Norman, for \$15. for each contract burial, was agreed upon.

Filing cases

The matter of bids for filing cases was taken up and all bids were held over for further consideration at the next meeting.

Bridge over The Commissioners heard a proposition for the building of a bridge across Ark.River the Arkansas River at Tulsa, the subject being presented by a committee from the Bonds Tulsa Commercial Club and the matter of a bond issue was discussed. The following resolution was presented for consideration by A.W.Lucas:

Bond Issue Contract. "Whereas, Geo W. and J.E.Piersol of Oklahoma City, Oklahoma, have submitted the following proposition to the Board of County Commissioners, Tulsa County;

PROPOSITION.

To the Honorable Board of County Commissioners, Tulsa County, Tulsa, Oklahoma.

Gentlemen:

In connection with the proposed issuance of Bridge Bonds by Tulsa County, Oklahoma, for the purpose of constructing a bridge across the Arkansas River in Tulsa County, we will agree, for a ree of one-fourth of one percent of amount of bonds issued, said fee to be payable thirty days after said bonds have been approved by the Attorney General of Oklahoma; to act as counsel and direct the proceedings covering the issuance of said bonds, we will represent you before the County and State officials in obtaining the approval of said bonds, and furnish all necessary forms and blanks free of cost, except blank ballots and blank lithographed bonds. You to furnish printed ballots and pay to us cost of lithographed bonds, you to do all things and pass all necessary resolutions that may be necessary as requested by ourselves and counsel for the issuance of said bonds and to make them a legal and binding obligation. If there is no election called for the issuance of said bonds, or should we purchase said bonds of you, there will be no charge for our services, and this agreement to pay us a fee of one-fourth of one percent shall be null and void.
