and the Board of County Commissioners of Tulsa County, Oklahoma, being fully advised, finds that the order prayed for in petition would be for the benefit of the citizens of the unincorporated Town of Turley, Oklahoma, and the surrounding country, and for the benefit of the County of Tulsa, Oklahoma and its citizens and further finds that the franchise and permission prayed for should be granted, and that an order granting said franchise and permission prayed for should be entered.

IT IS, THEREFORE, By the Board of County Commissioners of Tulsa County, Oklahoma, in open session ordered that L W Kingdom be and he is hereby granted a franchise and a permit to erect along the streets and alleys, public roads and public highways in the unincorporated Town of Turley, Oklahoma, and on the public highways and roads in and surrounding the following described real estate in Tulsa County, Oklahoma:

in accordance with the orders of the County Engineer, all and any poles, wires, lines, apparatus and other equipment necessary to the installation of telephone service in and to the unincorporated Town hereinbefore mentioned and the surrounding country, as well as poles and other equipment along and over the streets, alleys and public highways of the unincorporated Town of Turley, Oklahoma, and the public roads and highways in the surrounding the hereinbefore described real estate in Tulsa County, Oklahoma.

IT IS FURTHER ORDERED that in case the said Board of County Commissioners of Tulsa County, Oklahoma, desire to improve any of the said streets alleys and public highways along which and over which this franchise and permission is granted, that the said L W Kingdom, his successors or assigns, will move back said poles at his own expense upon notice from the Board of County Commissioners of Tulsa County, Oklahoma or the County Engineer.

IT IS FURTHER ORDERED that said L W Kingdom shall be liable for all damages caused to any persons, corporation, structures or buildings by the erections of said poles wires, lines or apparatus, and shall relieve Tulsa County, Oklahoma, of any and all damages action or causes of action by reason of the construction of the said telephone system.

O R D E R

The following Resolution was introduced by Commissioner North, who moved its adoption, and the motion was duly seconded by Mr. Hedgecock.

WHEREAS, Public Service Company of Oklahoma has requested this Board to grant permission to said company to establish a pole line carrying electric wires for carrying electric wires for power purposes in this County, commencing at the North Line of the City Limits of the Town of Owasso, Oklahoma, and 21 ft. west of the center of the paved road and running north parallel with and 21 ft. west of the center of pavement to a point 21 ft. south of the north line of Sec. 30, T 21 N., R 14 E., thence East parallel and 21 ft. south of the north line of Sec. 30, T 21 N., R 14 E., to a point 21 ft East and 21 ft. south of the NW corner of Sec. 29, T 21 N., R 14 E., thence north parallel with and 21 ft east of the center of pavement, a distance of approximately $4\frac{1}{2}$ miles thence in a northeast-
