Pursuant to adjournment that Board of County Commissioners met in regular session in the office of the County Clerk, at the hour of two o'clock P. M. with all members present and the following proceedings were had:

A motion was made by F. M. Wooden and seconded by Ira Short that the Certificate of County Election Board as to the result of the election in Dawson Township be approved and spread of record, which motion is as follows, to-wit:-
Tulsa, Oklahoma, September 7th, 1921.

To the Board of County Commissioners,
Tulsa County, Oklahoma.

We, the undersigned the duly qualified and acting members of the county Election Board of Tulsa County, State of Oklahoma, hereby certify:

That on the 7th day of September, 1921, said Board met in special session in the Court House in the City of Tulsa, Oklahoma, the County seat of said county in said State, with two members present, for the purpose of canvassing the returns of the election held by Dawson Township in said County and State on September 6th, 1921, on the question of issuing bonds of said township for the purpose of providing funds for the purpose of the improvement of roads by permanently building and constructing said roads in said township in accordance with the provisions of the Statutes and constitution of the State of Oklahoma.

That after carefully canvassing the returns of said election, and listing the result thereof upon a book prepared for that purpose, we found that the vote cast was as follows:
