In the matter of the application of Sand Springs Home for permission to use Public Highways for water lines the following Resolution was presented by Mr. North who moved its adoption and the motion to adopt was duly seconded by Mr. Shaver, and the Chairman ordered the Resolution read:

R E S O L U T I O N

On this the 2nd. day of June, 1926, at a regularly called meeting of the Board of County Commissioners of Tulsa County, Oklahoma, the following resolution was presented and adopted:

WHEREAS, the Sand Springs Home, an Oklahoma Corporation, is engaged in the business of supplying water for domestic and commercial uses in the vicinity of the City of Tulsa and has a supply of water for such uses from the Shell Creek Reservoir and from the Spavinaw Reservoir of the City of Tulsa by virtue of a contract with the City of Tulsa; and

WHEREAS, the said Sand Springs Home is equipped to furnish water for domestic and commercial uses to the District between the City of Tulsa and the City of Sand Springs and the residents of said District are in urgent need of a water supply, and

WHEREAS, it is necessary in order to furnish such supply that the said Sand Springs Home be granted permission to use the streets, alleys and highways in said District for the purposes of laying water mains and written petition for such permission has been filed with this Board, and

WHEREAS, the Board finds that the use of said streets, alleys and public places is necessary for the proper installation and maintenance of said water system and that said system is urgently necessary for the health and convenience of the residents of that part of Tulsa County affected.

IT IS THEREFORE ORDERED: That the Sand Springs Home a corporation be and it is hereby granted the right and authority to lay its water mains and other necessary equipment for water purposes in the streets, alleys public highways and rights of way and all public places in the District lying between the west boundary of the City of Tulsa and the East boundary of the City of Sand Springs and extending from the Arkansas River north to such places as there may be consumers for such water. Said Sand Springs Home shall have the right to make all excavations and conduct such other operations on the streets alleys, public highways and rights of way and all other public places in said District as may be necessary or proper for the laying, maintaining,
