"PROCLAMATION

Proclamation is hereby made that on the 13th day of March, 1915, th Proclama Board of County Commissioners of Tulsa County, Oklahoma, adopted a Resolution as follows:

## 'RESOLUTION AND ORDER

Be It Resolved, that the Board of County Commissioners of Tulsa County, Oklahoma, deem it advisable to issue bonds of said county in the aggregate principal sum of Two Hundred Thousand (\$200,000.00) Dollars, bearing interest at the rate of five percent per annum, payable semi-annually, the purpose for which the money derived from the sale of said bonds to be used in constructing a bridge across the Arkansas River at or near the City of Tulsa in said County. Said bonds are to run from five years to twenty years from their date.

"Said bridge to be known and designated as Bridge No. 33 and to be located across the Arkansas River and described as follows, towit: Beginning at a point on the north bank of said river, approximately south Eleven deg. no Min. west, a distance of 1330 ft. more or less, from the northeast corner of the northwest quarter of Section 11, Township 19, north, Range 12 east, Tulsa County, Oklahoma; running thence approximately south 39 deg. 30' west, a distance of 1400 feet, more or less, to the south bank of said river.

"That the election therefor shall be held on the 12th day of April, 1915, and the polls shall be opened at seven o'clock A.M. and closed at six o'clock P.M. and the names of the Judges and Clerks for each voting precinct shall be as fol-
