Coming on for hearing is CZ-79, Raymond Christian (Bevens), Applicant, a tract located on the SW corner of 91st street and 193rd E. Ave. Young stated that the \$50. publication fee had been paid and the hearing would proceed. Mr. Steve Compton, TMAPC, was present and stated that the Planning Commission voted to recommend the described property be rezoned CS on the north 2½ acres of the 5½ acre tract (317' X 343'). Mr. Raymond Christian, Applicant, stated he owns the South 3½ acres of the described property and owns the 3 residential homes. One home is already a Beauty Shop, and he would like to turn the other two homes into a School of Cosmetology and Antique Shop. Harris questioned the 100 year flood plan? Christian said he and the other Applicant Mr. Bevens had been working on bring the land up 6" above the intersection.
