SUPPLEMENTAL REPORT ON AUDIT OF OUTSTANDING CLAIMS
FISCAL YEAR OF 1922-23 OF TULSA COUNTY, OKLAHOMA.

Sir:

Since filing the report of an audit of outstanding and unpaid claims for fiscal year of 1922-23 General Fund of Tulsa County, Oklahoma, I have discovered that certain claims were inadvertently classed as charges against the fiscal year 1922-23, when, in fact such claims are a proper charge against the fiscal year of 1923-24.
