Motion was made by Mr.North seconded by Mr.Hedgecock, that Mr.J.C.Smith be and he is granted an allowance of \$10.00 per month effective from and after June 1st.1926.

R E S O L U T I O N

The following Resolution was offered by Member W L North.

WHEREAS, by reason of the congested condition of the County Court House, there is not at thime time, nor has there been for many months last past, sufficient space or room in said building to transact in an orderly way the public business, and it is the judgment of this Board that by reason of such congestion, it is not onlyadvisable but a practical necessity to provide rooms and quarters for various of the courts and offices now in the County Building, and

WHEREAS?The Court Arcade Building, a structure now about completed, would be a suitable and desirable place to house the Court ofmCommon Pleas, and its various employees, and to enter into a lease for adwquate quarters in said building would greatly relieve the present congested condition of the County Building, and

WHEREAS, The Board of County Commissioners can acquire for such purpose the West Half (W $\frac{1}{2}$) of the second floor of the said building, which would provide four (4) court rooms, four (4) rooms for judges of said Court, two (2) rooms for court reporters and an office for the Clerk of said Court, including a steel vault, and that the space herein mentioned would be ample for the present business and purpose of said Court, and it is the judgment of this Board that such space as herein in this Resolution mentioned in said building sould be leased for one year upon the best terms at which the same may be obtained, together with the privilege of renewal of the same from year to year, not exceeding in a ll a period of five years.

NOW,THEREFORE, BE IT RESOLVED, By the Board of County C,ommissioners in regular meeting assembled that the Chairman of this Board Be and he is hereby authorized instructed and empowered to enter into a formal lease with the owners of the Court Arcade Building for a period of one year, and for the amount of space in this Resolution specified upon the best terms that may be made therefor.
