in force asuchfadditional time until the parties of the second part have been satisfied that any and all patent or royalty charges have been satisfied by the Contractor.

The contractor has personally examined the proposed work and acquainted himself with all the attending conditions, as well as the plans, in order that no mino understanding may later arise as to the character of the work or the amount of the same to be done.

Active progress on the work covered by this contract shall be commenced by the 10th day of June, 1918, and the same shall be completed on or before the 10th day of October 1918, and for such time consumed by the contractor in the completion of the same after the 10th day of October, 1918, if in the opinion of the County Engineer due diligence has not been exercised by the contractor, then and in such event the contractor shall forfeit to Tulsa County the sum of \$10.00 per day for each and every day thereafter.

And in consideration of the completion of the work herein described, and the fulfillment of the stipulations of this contract and agreement to the satisfaction and acceptance of the County Engineer and the Oklahoma Department of Highways, the parties of the second part agree to pay to said contractor by means of a ash warrant, the following contract price,-

TWENTY SEVEN THOUSAND AND SEVEN HUNDRED DOLLARS \$\$27.700.00)

the same to be paid upon monthly estimates of the County Engineer, less twenty five per cent of the same to be retained until the final completion of the work and the acceptance of the same by the County Engineer and the Oklahoma Department of Highways with the further consideration that in event it becomes necessary to do additional work over and above that shown upon the plans, the same shall be paid for at actual cost, plus fifteen (15%) per cent, when the same has been ordered in writing by the County Engineer.

In event of strikes, the action of the elements, or other unavoidable causes beyond the control of the contractor, then and in such event the time for completion under this contract shall be set ahead the same number of days as in caused by the causes above set out.
