

R E S O L U T I O N

WHEREAS, The Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to GEO. M GOODWIN of a deed conveying to him for a consideration of Fifty Four (\$54.16) the following described lot, to-wit:

Lot 4, Blk. 5, North Turley Add to Turley.

AND, WHEREAS, The sale of said lot by the County Treasurer was made pursuant to Section 9845 of the Compiled Oklahoma for 1925, whereby the County Treasurer is authorized to sell lands and lots purchased for the County by him as tax re-sale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Skiatook News, the official paper of the County of Tulsa, the said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, of the state of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of Oklahoma, hereby approve the sale of said lot made by the County Treasurer to GEO M GOODWIN for a consideration of \$54.16 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to him a deed conveying to him all the right, title and interest of the County of Tulsa, of the State of Oklahoma, in and to said lot and the County Clerk of Tulsa County is hereby directed to attest his signature and attach thereto the seal of this office.
