 Beginning at a point 138.3' East of the Northwest corner of Lot 7, Block 2 Aviation View Subdivision thence south 310'; thence East along the South line 50' to a point; thence North 310' to a point; thence 50' West to the point of beginning,

acquired by virtue of easement deed recorded in the office of the County Clerk in Book 1871. at Page 399.

BE IT FURTHER RESOLVED that the Chairman be, and he is hereby authorized and directed to execute and acknowledge this relinquishment in order that it may be recorded in the Deed Records in the office of the County Clerk of said County.
