Among other business, the following procedure was had:

Upon motion of Commissioner Gray, seconded by Commissioner Bridges, the following resolution waspresented, moved, and adopted:

## RESOLUUTION

WHEREAS, There is now on deposit in Sinking Fund Account of Water Improvement District No. 5 of TulsaCounty, Oklahoma, in the hands of the County Treasurer of Tulsa County, Oklahoma, after payment of all interest due on the bond issue before the maturity date of the next installment of said assessment, levied to create a fund with which to pay said bonds, sufficient to constitute a surplus over and above the necessary requirements of said fund and to pay the principal and intereston bonds numbered 22-23-24-25 up to October 1, 1933. These bonds are being retired in numerical order as required by the statutes.

NOW, THEREFORE: Since there is on hand with the County Treasurer a surplus over and above the amount necessary to take care of all interest and principal falling due, It is hereby resolved by the Board of Commissioners of Tuka County, Oklahoma, that Water Improvement District No. 5 bonds numbered 22-23-24-25 be called in and paid, same being in numerical order that are outstanding. It is further resolved that a copy of this resolution be sent to the Fiscal Agency of the State of Oklahoma in the City of New York, State of New York, and they be notified that after October 1, 1933, no further interest will be paid on bonds numbered 22-23-24-25 Series "A" bonds, Water Improvement District #5.
