## R E S O L U T I O N

Tulsa, Oklahoma, this the 19th. Day of Nov. 1928.

The Board of County Commissioners, Tulsa County, Oklahoma, in regularly adjourned meeting this the 19th. day of November, 1928, with all three members present, passed the following Resolution:

WHEREAS, on the 5th. day of December, 1927 and on the 23rd. day of January, 1928, this Board, by resolution made contracts with Bert C. Hodges, whereby the said Bert C. Hodges was given authority, under the tax ferret laws of Oklahoma to discover and list property that may have been omitted from the tax rolls, property belonging to corporations names in such contracts or resolutions abovementioned, and

WHEREAS, said contracts referred to above do not take into consideration, nor do they cover the subsidiaries belonging to or being controlled by said corporations, and

WHEREAS, it is necessary, to the full success of the operation of said contracts that such subsidiaries be included,

NOW, THEREFORE, BEIT RESOLVED, By the Board of County Commissioners of Tulsa County, Oklahoma, in meeting assmebled that said contracts by resolutions dated the 5th. day of December, 1927 and January 23rd. 1928, respectively be and are hereby extended to include such subsidiaries.
