WHEREAS, it is the desire of this Board to estimate to be received in the Jounty Sinking Fund from motor vehicles license tax and gasoline tax the amount of \$30,585.12 which amount is 8.8914% of the estimated income to be received from these sources during the fiscal year 1936-37.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Tulsa County, Oklahoma:

- 1. The Excise Board be requested to increase the estimated income to be received in the County Sinking Fund from gasoline and automobile tax from \$29,585.68 to \$30,588.12, divided as follows: Automobile license tax \$19,046.16; gasoline license tax \$11,541.95.
- 2. That the appropriation heretofore requested in Account #13 of the County Highway Fund in the amount of \$75,469.99 be reduced to \$74,467.55.
- 3. That the income estimated to be received for the benefit of the County Highway Fund from Automobile license tax to be fixed at \$195,162.80 and from gasoline tax \$115,265.70.

BE IT FURTHER RESOLVED that a certified copy of the within Resolution be served upon the Excise Board of Tulsa County, Oklahoma, to be affixed to and made a part of the County budget now on file.
