MONDAY, October 2nd, 1933.

The Board of County Commissioners met in regular session, on Monday, October 2nd, 1933, at the hour of 10:00 o'clock A.M., with all members present: John H. Miller, Chairman, J. B. Gray and H. E. Bridges, Members. Andy Stokes, County Clerk.

Motion was made by Commissioner Gray, that all claims for salaries and other claims as itemized be allowed, subject to approval of the tentative Budget by the Excise Board. Motion was seconded by Commissioner Bridges, the three Commissioners voting in the affirmative, motion was declared carried.

Motion was made by Commissioner Gray, that Superior Policy #GC-74 written on the Tulsa County Farm in the sum of \$1,000.00 by Lowe & Harwood be cancelled and same returned. Motion was duly seconded by Commissioner Bridges and by the Chairman declared carried.

Motion was made by Commissioner Gray, that the County Commissioners disallow all Attorney fees for paupers over \$10.00 in the District court. Motion was duly seconded by Commissioner Bridges and by the Chairman declared carried.

Upon motion of Commissioner Gray, seconded by Commissioner Bridges and Chairman Miller, a recess is hereby taken until 2:00 o'clock P. M. Monday, 2nd, 1933.

The Tulsa Board of Commissioners re-convened pursuant to recess heretofore taken at the hour of 12:00 o'clock noon.

O R D E R

WHEREAS, the Treasurer of Tulsa County, Oklahoma, has filed and presented to the Board of County Commissioners of the County of Tulsa, State of Oklahoma, an application for the issuance to M. F. STEELE of a deed conveying to him for a consideration of Thirty-Two and No/100 (\$32.00) Dollars the following described lot:

Lot 5, Block 50, Original Town of Collinsville.

AND WHEREAS, the sale of said lot by the County Treasurer was made pursuant to Section 9745 of the Compiled Statutes of Oklahoma of 1921, and amendments thereto, whereby the County Treasurer is authorized to sell lands purchased for the County by him at tax resale, and

WHEREAS, due notice has been given and published by the County Treasurer in the Tulsa Daily Legal News, the official paper of the County of Tulsa, that said County Treasurer would on this date apply to the Board of County Commissioners for an order approving said sale, and directing the issuance of deed therefor, and

WHEREAS, pursuant to such notice, hearing on such sale has been had by the Board of County Commissioners, and no other person having appeared to bid a higher price for the purchase of said lot, and the County of Tulsa has no need for said lot for any purpose required and provided by law whatsoever.

NOW, THEREFORE, the Board of County Commissioners of the County of Tulsa, State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of the State of Oklahoma, hereby approve the sale of said property so made by the County Treasurer to M. F. STEELE for a consideration of \$32.00, and it is hereby ordered that the Chairman of the Board of County Commissioners execute to M. F. STEELE a deed conveying to him all the right, title and interest of the County of Tulsa, State of Oklahoma, in and to said property, and the County Clerk of Tulsa County is hereby directed to attest with his signature and attach the seal of his office.
