APPLICATION TO FILE AN AMENDMENT TO DEPARTMENT F-3, COUNTY CLERK, ACCOUNT 3, ACCOUNTING AND RECORDING RECORDS AND SUPPLIES, AS CONTAINED IN THE FINANCIAL STATEMENT AND SUPPORTING SCHEDULE OF THE GENERAL FUND OF TULSA COUNTY, FOR THE FISCAL YEAR ENDING JUNE 30th, 1936.

TO THE HONORABLE EXCISE BOARD OF TULSA COUNTY,

Gentlemen:

Application is hereby made by the undersigned as County Clerk of said County and charged with the duties of preparing a financial statement of the several funds of Tulsa County for the fiscal year ending June 30th, 1936, hereby makes application to file an amendment to the financial statement of the General Fund of said County and in support of this application, said County Clerk hereby certified as follows:

FIRST: That in preparing a list of claims and contracts pending against Account F-3, County Clerk, Accounting and Recording Records and Supplies, the amount set out was \$321.35.

SECOND: That on June 30th, 1936, there was a total of outstanding claims and contracts pending and unpaid of \$658.25, thereby leaving an error in that item of \$336.90.

THIRD: That the inclusion of the said omitted claims and contracts in the financial statement under the title of CLAIMS AND CONTRACTS PENDING increased the amount thereof from \$51,707.40 to \$52,044.30 and thereby reduces the surplus shown on line 36, Exhibit "D", Page 4, General Fund from \$12,960.01 to \$12,623.11.

Hereby attached marked Exhibit "A" and made a part of this application find statement in detail supporting the facts as herein set forth. Therefore, it is hereby requested that this amendment be allowed by your Board and attached to the financial statement and estimate of needs of the General Fund of said County as filed with your board.
