Pursuant to recess heretofore taken, the Board of County Commissioners re-convened at the hour of 10:00 o'clock A.M., with the following members present: John H. Miller, Chairman; Harry L. Hopkins, member. Andy Stokes, County Clerk. J.B. Gray, member, absent.

Reading of the minutes of the previous meeting was dispensed with and there being no objection to the same they were ordered to stand approved.

Motion by Commissioner Hopkins, seconded by Commissioner Miller, that the affidavit of erroneous assessment on Lot 77, Block 9, South Side Addition to City of Tulsa, filed by the Tulsa Building & Loan Association, Oklahoma, be and the same is hereby approved and the county clerk is hereby instructed to issue a certificate of error on the assessment valuation reducing the valuation for the year 1930 from \$21,000 to \$14,000; 1931 from \$18,000 to \$12,000, and 1932 from \$14,400 to \$12,000. The members presenting voting in the affirmative, motion declared carried.
