Now, on this 7th. day of January, 1924, the Petition of the Oklahoma Union Railway Company, a corporation, praying for the right and privilege to place its tracks over, across and along the following streets, alleys, and highways to-wit:

Over and along Eleventh Street, along the North side of the East Half of the Northeast Quarter of the Northwest Quarter of Section Seven (7), Township Nineteen (19) North, Range Thirteen (13) East, Tulsa County, Oklahoma.

Over and along Eleventh Street, along the South Side of Blocks Two (2) and Three (3) Fleetwood SubDivision.

Over and along Eleventh Street, from and through the intersection of Atlanta Avenue, to and through the intersection of Delaware Avenue.

Over and along Delaware Avenue, from and through the intersection of Eleventh Street, to and through the intersection of Thirteenth Street.

Over and along Thirteenth Street from and through the intersection of Delaware Avenue to and through the intersection of Florence Avenue.

Over and along Thirteenth Street, from and through the intersection of Harvard Avenue to and through the intersection of Louisville Avenue.

Over and along Louisville Avenue from the North line of Eleventh Street, to the South Line of the Northwest Quarter of the Southwest Quarter of Section Nine(9) Township Nineteen (19), Range Thirteen (13) East, Tulsa County, Oklahoma.

Over and across the Public Road on the Section line between Sections Nine (9) and Sixteen (16), Township Nineteen (19)
