Pursuant to adjournment the Board of County Commissioners met in the office of the county Clerk, with all members present, the following proceedings were had.

A motion was made by F. M. Wooden and seconded by Ira Short that the resolution providing theform of bond for the Bond Issue of Dawson Municipal Township, be and the same is hereby approved this 4th day of October, 1921. All members voting in the affirmative, the samewas by the Chairman declared carried.

A motion was made by F. M. Wooden and seconded by Ira Short that the petitions filed by the voters of Dawson Township requesting the early sale of the bonds authorized by the special election on September 6th, 1921, and that contracts be let at an early date as possible in order that said roads may be commenced and completed as soon as possible, be received and approved, and that the County Engineer be instructed to make surveys, plans, profiles and estimates of cost and commence and complete all things necessary to promote the advancement of the issue, and the completion of the foats in said township, as soon and as quickly as possible.

Said motion twas then put to a vote, and having received all of the votes of the Board, the same was by the Chairman declared carried.

A motion was made by F. M. Wooden and seconded by George E. Gilmore that total the three month's salary in the/amount of \$360.00 for services rendered by Sada Grommett, city Home Demonstration Agent, be and the same is hereby ordered paid, and the County Clerk is hereby authorized to issue warrant in the amount of the said \$360.00, in payment of the same. Whereupon the chairman put said motion to a vote and the vote thereon was as follows:

Said motion having received the entire vote of the Board, the same was by the Chairman declared carried.

At an adjourned meeting of the Board of County Commissioners of Tulsa County, Oklahoma, held on the fourth day of October, 1921, the following resolution was introduced by F. M. Wooden who moved its adoption, the motion for the adiption being seconded by Ira Short.

THEREFORE, BE IT RESOLVED, that the Honorable State Examiner and Inspector be and he is hereby requested without unnecessary delay to addit all of the Justices of the Peace of said county and examine and inspect their several records and that the Justices of the Peace be audited for a period ocvering six (6) years, and ending on January 3rd, 1921, and that the Justices of the Peace of the various districts cutside of the City of Tulsa be audited for a period of four (4) years, and ending January 3rd, 1921; and

AND BE IT FURTHER RESOLVED that on the completion of such audit that the State Examiner and Inspector be and he is hereby requested to audit such Justices of within said county as may be designated by this Board for the period from January 3rd, 1921, to October 1st, 1921.
