WHEREAS, said Caterpillar Tractor and Leaning Wheel Grader being in a state of bad repair and not generally serviceable for the uses and purposes of the Highway Department, to which said Caterpillar Tractor and Leaning Wheel Grader belongs, and was purchased and paid for from County Highway Funds; and,

WHEREAS, the Highway Department is in need of a Motor Grader, and has found that a trade or exchange can be made with Herd Equipment Company for a new Galion 102 Tandem Motor Grader, Serial #MD-8170, Motor # UDF-20132-Z-1, in exchange for the Caterpillar Tractor and Leaning Wheel Grader, and a further consideration of payment by Tulsa County to the Herd Equipment Company the sum of Six Thousand, Two Hundred Forty-Seven & No/100 Dollars (\$6,247.00).
