on the West Tulss side:

- (2) For a roadway 30' wide with two 5' sidewalks, with single track election railway, ---- \$185,950
- (3) For a 38' roadway and two 5' sidewalks, with double track electric railways, ------\$233,400

The above figures include the bridges complete, including the street railway tracks, ties, etc., in place, and the trolley poles; but do not include the trolley wires and overhead work. If the ties and rails were omitted from the present construction the two first figures would each be reduced \$5000, and the latter figure would be reduced about \$10,000.

Such arrangement, of course, would necessitate tearing up the pavement and a certain amount of paving base in order to place the tracks at some future time.

We have been advised by the Engineers of the War Department that it will be necessary to secure a special act of Congress for the construction of the bridge. In previous similar cases we have secured the approval of the War Department for construction to proceed pending the passage of such an act, and we believe similar action may be taken in this case.

The drawings as shown will generally control the construction proposed, but there may be some slight variations during the working up of the details. We beg to request that you come to an early decision regarding the width of roadways desired, and advise us concerning any other features you may wish to have included in the final design so that we may proceed with the least possible delay with the preparation of the plans.
