This meeting was missed on account of rains and High water.  
I would like you to make appointment from this township as provided for in Book 380.

## Broken Arrow

On information that Broken Arrow, the city, was a township in its self I held a meeting for election of these directors, subject to the approval of the board of county commissioners.  
Meeting held Thursday May 27th  
23 legal votes were cast  
M. C. Williams and Robert Pilgrim were elected township and county fair directors from Broken Arrow.  
No votes against fair bill.

## Boles Township

Meeting held Thursday May 27th  
20 legal votes were cast  
D. A. Wilson and Frank Haymes elected township and county fair directors.  
No votes against the approval of fair bill.

## Bixby

Meeting held Friday May 28th  
O. C. Henderson and D. D. Wamsley elected township and county directors from Bixby township.  
26 legal votes were cast.  
No votes were cast against the bill.

## Jenks

Meeting held Monday May 31  
J. F. Wulff and Walter Kinsey elected directors to the township and county fair from this township  
25 legal votes were cast.  
two votes were against the fair bill being approved

## Glenn Pool

Meeting held Tuesday June 1  
H. B. Stone and M. T. Self were elected directors to the township and county fair from this township  
25 legal votes were cast.  
No votes were cast against favoring the bill.

I would like to call to your attention that out of a total of 267 votes cast in the 11 meetings only three voters cast their decision against approving the bill. I decided to hold ballot election in order to give each man a chance to express his opinion on the bill.

As a further precaution I required each voter to sign his name to his ballot so that you may make personal check and know that there was no secret closet balloting in connection with these elections.

I feel that the farmers of Tulsa have approved the fair bill to a degree that will prompt your honorable body to assist us in securing the full amount provided for by the law, I am asking the limit this year, for as you know the expense of starting any thing of this kind, is much more than they will be in future after our organization has been perfected.

I ask your approval of these elections and that you declare the Fair Bill (House bill No 380) in full force and effect.

In addition I ask that you make appointments of directors to represent townships where no elections could be held, I would like to make personal recommendations in this connection, if you will permit.

I feel that this is the first big opportunity Tulsa county has had to show our own citizens and show the state at large that this is an agricultural as well as an oil and manufacturing county. Last year we took 8th prize at the state fair. This year with the organization as provided for in these elections we should be well up in the first column.
