The board of County Commissioners met in their rooms in the County Court House on July 1st, at 9:00 o'clock A. M., present Cyrus S. Avery, Tulsa and A. W. Lucas, Skiatook, also Lewis Cline, County Clerk, Ed. Baker, Bixby being absent.

The first business was approval of Ed. Dalton's bond as County Treasurer of Tulsa County, said bond being accepted by the Board of County Commissioners, he having filed his oath of office, and hasknow takes charge of the County Treasurers office.

The next business to come up was the bonds submitted by the First National Bank, Tulsa, for the special bridge fund of Tulsa County, said fund to be divided between the First National Bank, Tulsa, and the Exchange National Bank, Tulsa, in the amounts of \$100,000.00 each. The First National Bank presented their personal bond signed by C. E. Vandevoort, G. R. McCullough, L. K. Come H. O. McClure and P. E. Magee, said bonds approved.

The Exchange National Bank signed over temporarily to the County Commissioners, approved bonds in the amount of \$100,000.00 for the protection of their part of bridge fund, said bonds being accepted for the deposit of the \$100,000.00 bridge fund money.

Order was made and a contract signed whereby Arthur Farmer was given the contract to compare and complete the transcribing of the records of TulsaCounty, said contract being signed by Board of County Commissioners and County Clerk, and filed in the County Clerks office and approved.

An application of the Public Service Company having been filed with the County Clerk, across the highways and public roads in Sections Two (2) Three (3), Ten (10), Eleven (11), Twp. Nineteen (19), Range twelve (12), to erect poles and lay conduits and pipe and electric wires along said highways. Order was made and approved granting such right of way to the Public Service Company:

The application of the Public Service Company of Oklahoma, a corporation organized under the laws of the State of Oklahoma, for permission to erect poles and string wires and conduits thereon for the transmission of electricity, over, along, under, across and through the highways and public roads, beginning on the north side of the City Water Works property and to a point on the north side of the Cusden Refining Company plant, and along the section line between Sections Two (2) and Three (3) and Ten (10) and Eleven (11), of Township Nineteen (19), North, Range Twelve (12), East, and across the Arkansas River coming up for hearing before a meeting of the Board of County Commissioners of Tulsa County, Oklahoma, and the same having been duly considered.

NOW THEREFORE: the said Board of County Commissioners of the County of Tulsa, State of Oklahoma, hereby grants the said Public Service Company of Oklahoma permission to erect poles and string wires and conduits over, across, along, under and through the highways and public roads above described, and over the Arkansas River, and across and under the same, and grants the said Company permission to do any and all necessary acts to properly transmit electricity as above stated, all of said work to be
