

SATURDAY, MAY 31, 1947

Pursuant to recess heretofore taken, the Board of County Commissioners reconvened at the hour of 10:00 o'clock A.M., with all members present: J. B. Gray, Chairman; Curtis Greer and Claude W. Bailey, Members. William P. Gable, Jr., County Clerk:

J. B. Gray, Chairman presiding, the following business was transacted.

Thereupon the petition of Charles Stunkard and others for the formation of a water improvement district came on for further hearing and it was made to appear that after the hearing of this Commission on said petition on May 29, 1947, was had, C. M. Pickrell filed a petition to withdraw from the proposed district the NE/4 NE/4 SW/4 of Section 6- 18N- 13 East, Tulsa County, Oklahoma. After hearing had, motion was made by Commissioner Bailey, seconded by Commissioner Gray and unanimously carried, the petition of C. M. Pickrell was denied.

It having been made to appear that the formal election resolution had not been completely drawn and it was moved by Commissioner Bailey, seconded by Commissioner Greer and unanimously carried that the further consideration of the petition of Charles Stunkard and others to form a water improvement district be passed to June 2, 1947, at 10:00 o'clock A. M., for the consideration of the election resolution for said water improvement district and all other matters pertaining to said petition.

Upon the instruction of the Chairman of the Board of County Commissioners, the following sealed bids for the Spybuck Bridge over Bird Creek were opened: Gaines Brothers bid in the amount of \$86,746.65, together with their bid check for \$4,500.00, and T. J. Anderson's bid in the amount of \$85,000.00, together with his bid check for \$4,500.00. Motion made by Commissioner Gray, seconded by Commissioner Greer, that these bids be and are hereby referred to the County Engineer for his compilation and report. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Gray, to accept the resignation of T. Richard McCullagh as Deputy Clerk of the Court of Common Pleas as of May 31, 1947. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made by Commissioner Bailey, seconded by Commissioner Greer, that the appointment of James W. Woodcock as Deputy Clerk of the Court of Common Pleas, at a salary of \$175.00 per month, to replace T. Richard McCullagh who resigned, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.

Motion made Commissioner Gray, seconded by Commissioner Greer, that the bond filed by James W. Woodcock, Deputy Clerk of the Court of Common Pleas, in the amount of \$1,000.00, and made by the Ohio Casualty Insurance Company of Hamilton, Ohio, be and the same is hereby approved. Upon roll call, all members voting in the affirmative, motion was by the Chairman declared carried.
