marketing problems and teaching them best methods of marketing their products and disseminating information to them and to others regarding the grading, packing and assembling of agricultural products for marketing and in the disseminating of market information helpful to farmers in their marketing problems, the County Commissioners agree to pay on the salary of an Assistant County Agent in Marketing the sum of \$..... per month and \$..... to apply on the expenses of said Assistantn County Agent in Marketing for a period of twelve (12) months beginning July 1st. 1926.

COLLEGE FUNDS AND EQUIPMENT.

In addition to the funds furnished by the County, the Extension Division of the Oklahoma Agricultural amd Mechanical College, cooperating with the United States Department of Agriculture, will pay One Hundred Ten (\$110.00) Dollars per month on the salary of County Agriculatural Agent, and will pay One Hundred Ten (\$110.00) Dollars per month on the salary of a County Home Demonstration Agent. The Extension Division of the Oklahoma Agriculatural and Mechanical college also agrees to furnish all agents employed with the franking privilege for the free use of the mails in sending of agricultural publications in the County, to furnish the agents necessary stationery, instructions and printed bulleting for their use and bulletins for the use of farmers in the County, both from the College and from the United States Department of Agriculture.

SUPERVISION:

The Extension Division of the Oklahoma Agricultural and Mechanical Collegemalso agrees to supervise the work of these agents, , carefully looking after the same to see that the work is done efficiently and in a manner to be of the largest possible benefit to the people of the County, and to pay the expenses of the agents when they are authorized to attend any meetings outside of the County on official business.

SPECIAL AID:

The said A & M College likewise agrees to send to the County special representatives to assist these agents onnspecial tasks, and to hold educational meetings for the benefit of farmers and to assist in every possible way in making the work in the County effective.

PAYMENT OF SALARY.

The Agents' salary should be payable on or after the first of each month on certificate from the Extension Division of the A & M College that the work has been duly performed and the Agent is entitled to pay.

CHANGE OF AGENTS: In case of any dissatisfaction with the work of the Agent, on the part of the A & M College or on the part of the County Commissioners, each shall notify the other party of such dissatisfaction and if the dissatisfaction cannot be removed and all parties fully satisfied, said agent shall be promptly removed. If an agent is removed by agreement between the parties another competent and satisfactory agent shall be selected to continue the work to the completion of the contract in the same manner as originally provided.
