price for the purchase of said land and the County of Tulsa has no need for said land for any purpose whatsoever.

NOW, THEREFORE, The Board of County Commissioners of the County of Tulsa, of the State of Oklahoma, in regular session assembled and pursuant to the aforesaid statutes of Oklahoma, hereby approve the sale of said land so made by the County Treasurer to them for aconsideration of \$111.65 and it is hereby ordered that the Chairman of the Board of County Commissioners execute to them a deed conveying to them all the right, title and interest of the County of Tulsa, of the State of Oklahoma, in and to said land and the County Clerk of Tulsa County is hereby directed to attest his signature and attach thereto the seal of this office.
