We are now rejoining other county officials in the development of the Land Records Management System. This System will be a model for other cities and counties throughout the United States. We, at the Clerk's office, wish to make it clear that we are and will continue to be team players.

Again, we will cooperate with the Commissioners on the transfer of these computers and the reactivation of the Land Records Management System to the extent the law allows."

The Chairman will prepare a letter for all elected officials to sign affirming each one's commitment to the development of the Land Records Management System.

The Board agreed to assume maintenance of River Parks' maintenance division trucks on a cost-reimbursement basis.

The Board approved a tentative 1985 Holiday Schedule for submission to the Presiding Judge.

The Chairman was directed to inquire into the matter of purchasing adjacent property at Haikey Creek Park.

The meeting was adjourned at 11:03 a.m.
