

Tulsa, Okla Nov. 16 1909-

Pursuant to call of County Clerk the Board of County Commissioners of Tulsa County met in County Clerk's office. Present W. L. North, C. H. Cleveland & George Mc Keehan. On motion of Board the report of the Election Board was ordered to be spread upon the minutes of Commissioners Proceedings.

On motion of Board that portion of territory recently annexed from Wagoner County to south of the Arkansas river was annexed and made a part of Bixby Township.

On motion of Board that portion of territory annexed to Tulsa County from Wagoner County north of the Arkansas River constitute a Township & that it be named Willow Springs Township.

In the matter of Road Petition of Lynn Lane Township to condemn a road in section 12-19-12 same was accepted and the following viewers were appointed John Kramer, Alva Danow & Sam Hunt together with the county surveyor. The date set Dec. 16 1909.

On motion of Mc Keehan seconded by Cleveland the Board employed C. H. Pittman to assist the regular officers in the discovery of property omitted from assessment for 1908 & 1909, as provided by law and entered into contract signed in duplicate a copy of which is on file with the County Clerk.

In the matter of road petition of Lynn Lane Township for road in Section 9 Township 19 Range 13 East, same was accepted and the following viewers were appointed P. W. Cunningham, F. J. Bowlin & J. C. Mitchell together with the county Surveyor, date set Dec. 16 1909.

The Oklahoma State Bank was made a county depository and authorized to make bonds on motion of Board. The bid at par of First Nat Bank of Broken Arrow for Bonds of Try Drama District No. 1. was on motion of Board accepted.
